ODLUKU

o ukidanju prava na dodijeljenu stipendiju u slučaju prelaska na drugi studijski program

Član 1.

Utvrđuje se da stipendirani student IUS u cijelosti gubi pravo na dodijeljenu stipendiju u slučaju prelaska na drugi studijski program.

Član 2.

Stipendirani student iz člana 1. podrazumijeva studenta I ili II ciklusa studija koji uživa pravo na popust po bilo kojem osnovu, a posebno po osnovu: testiranja, sporazuma o zajedničkoj saradnji, OSYM testa, kvalifikacijske stipendije, humanitarne stipendije, stipendije za istaknute sportiste, umjetnike i nadarene studente, stipendije po osnovu upisanog brata/sestre (studenta), stipendije za članove porodice uposlenika, stipendije za djecu radnika IUS, studenta –demonstratora, stipendije po osnovu uspjeha u prvom ciklusu studija i dr.

Pursuant to the Article 9 of the Rulebook on Awarding Scholarships to the Students of First Cycle of Studies at the International University in Sarajevo, no. FRO-11/02-2020/10 as of February 11th 2020 and item VII of the DECISION on scholarship criteria for second study cycle no. FRO-11/02-2020/10-1 as dated February 11th 2020, the President of the Board of the Foundation for the Development of Education, brings the following determination

DECISION

on cancelation of awarded scholarship in case of transfer to another study program

Article 1

In case of transfer to another study program, it is determined that the IUS scholarship student in full loses the right on awarded scholarship.

Article 2

The scholarship student referred to in Article 1 means a student of the I or II cycle of studies who enjoys the right to discount on any basis, but not limited to the basis of: testing, mutual cooperation agreement, OSYM test, qualification scholarships, humanitarian scholarships, scholarships for prominent athletes, artists and gifted students, scholarships based on the enrolled brother/sister (of student), scholarships for family members of employees, scholarships for children of IUS employees, student-demonstrators, scholarships based on success in first cycle of studies, etc.

Article 3

The decision shall enter into force on the day of its adoption.
