ODLUKU
o kriterijima za dodjelu stipendija za drugi ciklus studija

I

Utvrđuju se kriteriji za dodjelu stipendija studentima koji se upisuju na drugi ciklus studija počev od akademske 2022/2023 godine, na Internacionalnom univerzitetu u Sarajevu, kako slijedi:

OSNOV ZA STIPENDIJU	PROCENAT	POSEBNI USLOVI ZA OSTVARIVANJE PRAVA NA STIPENDIJU
Radnici IUS-a i njihovi srodnici u prvom stepenu (djeca)	25%	Najmanje jedna godina u radnom odnosu na IUS-u, i pozitivna ocjena radnika od strane rektora, odnosno generalnog sekretara
Diplomanti IUS-a	25%	Završen studij
Diplomanti drugih univerziteta iz BiH	10%	Diplomanti sa završenim studijem u akademskoj 2021/2022 godini
Državljeni BiH ili Republike Turske zaposleni u državnim organima BiH ili Republike Turske	10%	Po zahtjevu davaoca
Student demonstrator/Scholarship asistent	100%	Odluka dekana o imenovanju studenta demonstratora/Scholarship asistenta

II

Stipendija se izražava u procentu koji predstavlja popust na cijenu školarine za obračunski period.

III

Stipendija se dodjeljuje za period nominalnog trajanja studija. Osim u slučaju zastoja studija zbog formalnog odobrenja mirovanja prava i obaveza statusa studenta, dodijeljena stipendija se računa u okviru kontinuiranog vremenskog perioda od jedne godine, računajući od dana sticanja statusa studenta.

IV

U slučaju da student ispunjava uslove za stipendiju po više navedenih osnova, ostvaruje pravo na najveći pojedinačni procenat stipendije.

V

U slučaju prestanka osnova na temelju kojeg je dodijeljena stipendija, student nastavlja koristiti stipendiju po drugom osnovu za koji ispunjava uslove, uz ograničenje ukupnog trajanja prava na stipendiju (zajedno sa prethodnim osnovom).

VI

Situacije u kojima se stipendija ukida:

- a. protekom perioda za koji se stipendija dodjeljuje,
- b. gubitkom statusa studenta IUS-a,
- c. izricanjem disciplinske mjere studentu ili zbog akademskog neuspjeha studenta,
- d. prestankom statusa studenta demonstratora, odnosno „Scholarship asistenta“.

Ukidanje stipendije utvrđuje se posebnom odlukom rektora, a primjenjuje od narednog semestra od dana donošenja odluke. U nastavku studija, student kojemu je ukinuta stipendija plaća punu cijenu školarine.

VII

Dodijeljena stipendija u pravilu važi samo za jedan program studija. U slučaju prelaska studenta na drugi program studija, Rektor uz konsultaciju sa Osnivačem odlučuje o pravu na nastavku korištenja stipendije.

VIII

Na situacije koje nisu obuhvaćene ovom Odlukom supsidijarno se primjenjuju odredbe važećeg *Pravilnika o dodjeli stipendija studentima prvog ciklusa studija na Internacionalnom univerzitetu u Sarajevu.*

IX

Uslovi dodijeljeni po osnovu odluka broj: FRO-11/02-2020/10-1 i FRO-11/06-2021/84 kao i drugih odluka koje reguliraju istovrsnu materiju, ostaju nepromijenjeni za generaciju studenata koja je upisana prije donošenja ove odluke.

X

Ova odluka stupa na snagu danom donošenja.

Pursuant to the Article 17 of the Statute of the International University of Sarajevo, number: IUS-SENAT-11-1980/2018 dated August 13, 2018, the Board of Trustees of the Foundation for the Development of Education, adopted *the following*

DECISION
on scholarship criteria for second study cycle

I

The scholarship criteria for students enrolling in the second cycle of studies starting from the academic year of 2022-2023, at the International University of Sarajevo is hereby determined as follows:

BASIS FOR SCHOLARSHIP	SCHOLARSHIP PERCENTAGE	SPECIAL CONDITIONS FOR SCHOLARSHIP
Employees of IUS and their relatives in the first degree (children)	25%	At least one year of employment at IUS, and a positive assessment of the worker by the Rector, or the Secretary General respectively
First Cycle Graduates of IUS	25%	Completed studies
Graduates of other universities from BiH	10%	Graduates with completed studies in the academic year 2021/2022
Citizens of Bosnia and Herzegovina and Republic of Turkey employed by state authorities of Bosnia and Herzegovina or Republic of Turkey	10%	Per request of grantor
Student demonstrator / Scholarship assistant	100%	Dean's decision on appointment of Student demonstrator/Scholarship assistant

II

The scholarship is expressed in a percentage that represents a discount on the tuition fee for the accounting period.

III

The scholarship is awarded for the period of nominal duration of studies. Except in case of suspension of studies due to formal approval for acquisition of a dormant student status, the awarded scholarship is counted within a continuous period of one year, starting from the day of acquiring the student status.



IV

If a student meets the requirements for a scholarship on several of the above basis, he/she is entitled to the highest individual percentage of the scholarship.

V

In the event of termination of basis of which the scholarship was awarded, student continues to use the scholarship on another basis for which he/she meets the criteria, with a limitation of the total duration of the right to the scholarship (together with the previous basis).

VI

Situations in which the scholarship is abolished:

- a. upon the expiration of the period for which the scholarship is awarded,
- b. loss of IUS student status,
- c. by imposing a disciplinary measure on a student or due to a student's academic failure,
- d. with termination of status of Student Demonstrator i.e. Scholarship Assistant.

The abolition of the scholarship is determined by a special decision of the Rector, and is applied from the next semester from the day of adoption of the decision. Student whom scholarship has been abolished, pays the full amount of tuition fee for further studies.

VII

As a rule, the awarded scholarship is valid only for one study program. In the event of transfer of a student to other study program, the Rector in consultation with the Founder, decides on the right of using the scholarship in the further study.

VIII

The provisions of the respective *Rulebook on awarding scholarships to students of the first cycle of study at IUS* shall apply to situations that are not covered by this Decision.

IX

Assigned criteria on the basis of decisions no: FRO-11/02-2020/10-1, FRO-11/06-2021/84 and other decisions regulating the same subject, remains applying for the generation of students enrolled before the bringing of this decision.

X

Decision enters into force upon its adoption.
