PhD Studies: summary of conditions for successful completion of studies

The study requires the completion of 180 ECTS points in the following way:

1. completion of eight (8) courses, each with 6 ECTS.
2. completion of at least 12 ECTS of scientific activities.
3. defense of the PhD dissertation with which is worth 120 ECTS.

Courses	48	PhD candidates are required to complete 48 ECTS of coursework. Scientific activity
Scientific Activity	12	assumes research work which results in publication such as a journal article published in peer review journal. Scientific activity (worth 12 ECTS), that is approved by the mentor, or a conference paper at a conference proceedings (worth 6 ECTS) approved by the mentor and Faculty Council, or reports in case of at least one month research visit at other research institution. Scientific activity can be completed at any time before scheduling doctoral thesis defense.
PhD Dissertation	120	In order to be eligible to defend doctoral thesis, PhD candidate is obliged to provide at least one published or accepted (DOI number is required) SCImago Q1/Q2/Q3 or SSCI journal paper which is related to his/her thesis work.
