BECOMING ELIGIBLE TO START FACULTY COURSES

2. Exemption from the Proficiency Exam

C) Proof of having successfully acquired minimum 60 ECTS at an English medium university, obtained no longer than two (2) academic years before the date of application at IUS (supported by transcript and other relevant documents).
