#### ANNOUNCEMENT

**For the student enrolment into the first year of the third study cycle at the faculties of the International University of Sarajevo for the 2017/2018 academic year**

I

International University of Sarajevo (IUS) plans to enroll **49** student into the first year of the third study cycle for the academic 2017/2018; specifically, **26** students who are citizens of Bosnia and Herzegovina and **23** foreign students. In case IUS does not enroll planned number of students from Bosnia and Herzegovina into specific study program, IUS reserves the right to enroll additional number of foreign students into that study program, up to the total planed number and vice versa. Enrollment will be carried out into the following faculties:

## II

On addition to fulfilling general legal conditions, the right to apply for admission to the third cycle studies (PhD program) have candidates who have completed Master studies in accordance to the Bologna model of studies, with earned 300 ECTS credits, as well as those who have completed post-graduate studies under the previous study model and who gained the title of master of science (Bologna and pre-Bologna master's study), and candidates who graduated outside of Bosnia and Herzegovina, and who are found to possess adequate qualification to continue their education after recognition of their foreign qualifications.

## III

Lectures for all study programs are conducted in English language only.

Doctoral studies last three years; i.e. six semesters and they carry 180 ECTS points.

Tuition fees for all faculties are 6,000.00 EUR, payable in Bosnian Mark as per medium exchange rate of the Central Bank of Bosnia and Herzegovina.

## IV

Eligibility to apply is the same for the citizens of Bosnia and Herzegovina and for foreign citizens for whom foreign diploma recognition process confirmed that they had acquired adequate education to continue their further studies or that they need to pass necessary courses from the second study cycle along with their third cycle studies.

Admission into the third cycle study is approved by the special committee appointed at each Faculty for the purpose of evaluating academic degree, the content of previous studies and scientific area in which the candidate did his/her research. The committee will evaluate how comparable is candidate's previous education and will decide if the candidate had to pass additional group of courses to be able to follow lectures of the desired study program, on which candidates will be informed thereof. After reviewing applications, IUS can in exceptional cases set interview with the certain candidates and make decision per that application based on that interview.

## V

### REQUIRED DOCUMENTS FOR ENROLLMENT

#### CITIZENS OF BOSNIA AND HERZEGOVINA

In order to enroll in the first year of the third cycle at IUS, applicants who are citizens of B&H must submit the following documents:

1. Application form in which applicants must indicate the faculty (and study program) to which he/she applies (available at [www.ius.ba](http://www.ius.ba) or at the Student Services),

2. Original and certified copy of the diplomas for the master studies and of the Certificate on grades achieved during the studies,

3. Copy of Bachelor degree diploma,

3. Official document for recognition of qualification for those who gained high school degree outside of Bosnia and Herzegovina or document showing that recognition procedure has been initiated. In exceptional cases, candidates can be admitted conditionally, before foreign high school recognition procedure is ended;

5. Motivation letter,

6. Recommendation letter,

7. Birth Certificate;

8. Certificate of Citizenship;

9. CV

10. Two photos, frame 6x4, and

11. Health Certificate;

### **FOREIGN CITIZENS**

In order to enroll in the first year of the third cycle at IUS, foreign applicants must submit the following documents:

1. Application form in which applicants must indicate the faculty and study program to which he/she applies (available at [www.ius.edu.ba](http://www.ius.edu.ba) or at the Student Affairs Office);

2. Original and certified copy of the diplomas for the master studies and of the Certificate on grades achieved during the studies,

3. Copy of Bachelor degree diploma,

4. Official document for recognition of qualification for those who gained their degree outside of Bosnia and Herzegovina showing that candidates completed education adequate for continuation of studies, or document showing that recognition procedure has been initiated. In exceptional cases, candidates can be admitted conditionally, before foreign qualification recognition procedure is ended;

5. Motivational letter

6. Recommendation letter,

7. Passport copy (with validity period of at least two years);

8. Certificate of no criminal record (not older than six months and only for foreign students who are doing residency permit through IUS services);

9. Health Certificate (for foreign students who are not doing residency permit through IUS services);

10. Two photos, size 6x4;

11. CV

Candidates applying for admission have to submit one of the following documents to prove their English language proficiency:

a. Certificate on achieving minimum scores at one of the following international English language exams:

- ~~IBT~~ Internet-Based TOEF (minimum 80), (in Turkey, taken only from University-run test centers\*)

- IELTS Academic (minimum 6.5) (taken only from British Council test centers\*)

\* TOEFL/IELTS Test scores obtained from any other test center (Private Language Courses or similar) will not be admissible as proof of language proficiency at the International University of Sarajevo.

Upon receipt of the "ORIGINAL" score sheet from TOEFL/IELTS, student will submit the score sheet "IN PERSON" to the ELS Director for review and interview. Test-taker copy cannot be accepted as proof of language proficiency. The validity period for these scores is as stated on the Score Sheet.

- b. Diploma for completion of undergraduate or graduate program in the country where English is official language.
- c. Proof of having successfully acquired at least 60 ECTS at English medium university, obtained no longer than two (2) academic years before the date of application at IUS (supported by transcript and other relevant documents).
- d. Diploma from one of the following high schools:
  - AICE diploma: Cambridge Advanced International Certificate of Education
  - IB diploma: International Baccalaureate;
- e. Proof that English language is native language of the candidate

Candidates who hold FCE certificate with a minimum grade B2 are exempt from ELS Placement exam and can directly sit for ELS Proficiency exam.

Candidates that do not submit document proving English language proficiency will take Proficiency Exam organized by IUS at the beginning of academic year.

In case candidate cannot meet criteria used for determining necessary English Language proficiency, candidate is obliged to attend English Language School.

Applications which are incomplete or not received on time will not be taken into consideration.

This announcement is open until the day set by IUS, but not later than January 31, 2018.

IUS will publish preliminary rank-list of all applicants and those who are admitted to the IUS faculties on the IUS notice board and IUS website after it is verified by the competent University body, within two days from the due date for submitting applications for enrolment.

Applicants have a right to submit an appeal on the preliminary rank-list within three days from the day it was published.

IUS will announce the final list of admitted students no later than five days after the preliminary rank list has

In case insufficient number of candidates applies for enrolment into particular study program, IUS reserves the right not to enroll students into that study program in 2017/2018.
