In accordance with Article 131 of the Law on Higher Education ("Official Gazette of Sarajevo Canton", 33/17), Article 39 of the Law on Labor (Official Gazette of FBiH 22/16) and Article 17 of Rulebook on Labor of the International University of Sarajevo, the Rector of the International University of Sarajevo has issued the following

DECISION

I

Monday and Tuesday, 12 August 2019 and 13 August 2019 will be non-working days at the International University of Sarajevo, for the occasion of celebrating Eid al-Adha.

II

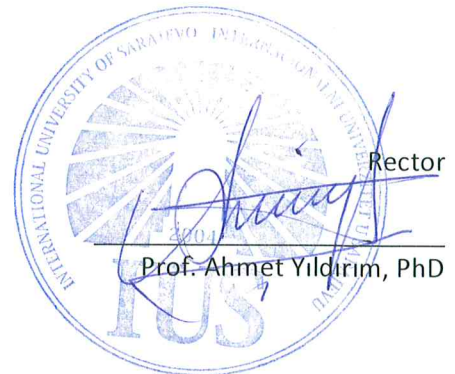
On this day classes will not be held and administrative units of the University will not be working, except for the regular on-duty employee at the University and specially determined on-duty employees at the Admissions Office.
