U skladu sa članom 56 stav (1) Zakona o visokom obrazovanju (Službene novine Kantona Sarajevo broj 33/17), Senat Internacionalnog univerziteta u Sarajevu, na svojoj sjednici održanoj dana 27.11.2018. godine, donosi sljedeću

ODLUKU

o izmjeni i dopuni Pravila studiranja za drugi i treći ciklus studija

I

Ovom Odlukom vrši se izmjena i dopuna Pravila studiranja za drugi ciklus studija broj IUS-SENATE 11-1153/18 od 25.05.2018. godine, kako slijedi:

II

U članu 12. Pravila studiranja za drugi ciklus studija, mijenjaju se stavovi (2) i (3), te se dodaje novi stav (4), koji sada glase:

„(2) Ova Pravila stupaju na snagu od početka 2018./2019. studijske godine, od kada se stavljaju van snage prethodna Pravila studiranja (broj: IUS-SENAT-11-2488-2/2014).

(3) Na osnovu pismenog zahtjeva studenta, Vijeće postdiplomskog studija može odobriti da se okončanje studija provede u skladu sa prethodnim Pravilima, ukoliko se očekuje da upisani student redovno okonča svoj studij najkasnije do kraja zimskog semestra 2018/2019. studijske godine.

(4) Vijeće postdiplomskog studija može, mimo zahtjeva i nakon roka iz prethodnog stava, odobriti da se okončanje studija provede u skladu sa prethodnim Pravilima, a što se cijeni u svakom konkretnom slučaju.“

III

Mijenja se član 29. Pravila studiranja za treći ciklus broj IUS-SENAT-11-1154/2018 od 25.05.2018. godine, te sada glasi:

Član 29.

(Stupanje na snagu)

„(1) Ova Pravila stupaju na snagu od početka 2018./2019. studijske godine, od kada se stavljaju van snage prethodna Pravila studiranja (broj: IUS-SENAT-11-2488-3/2014).

(2) Na osnovu pismenog zahtjeva studenta, Vijeće postdiplomskog studija može odobriti da se okončanje studija provede u skladu sa prethodnim Pravilima, ukoliko se očekuje da upisani student redovno okonča svoj studij najkasnije do kraja zimskog semestra 2018/2019. studijske godine.

(3) Vijeće postdiplomskog studija može, mimo zahtjeva i nakon roka iz prethodnog stava, odobriti da se okončanje studija provede u skladu sa prethodnim Pravilima, a što se cijeni u svakom konkretnom slučaju.“

Ovom Odluka validiraju se sva postupanja od datuma donošenja Pravila studiranja za drugi i treći ciklus studija, do datuma donošenja ove Odluke.

V

Ostale odredbe Pravila za drugi i treći ciklus ostaju nepromijenjene.

Pursuant to Article 56 paragraph (1) of the Law on Higher Education (Official Gazette of Sarajevo Canton No. 33/17), Senate of the International University of Sarajevo, at its session held on November 27, 2018 adopts the following

DECISION

On amendments of the study rules for second and third cycle studies

I

Study Rule for Second Cycle Studies at IUS, No. IUS-SENATE 11-1153/18, dated May 25, 2018 is hereby amended as follows:

II

In the Article 12 of the Study Rule for Second Cycle Studies at IUS, paragraphs (2) and (3) are amended and the new paragraph (4) is added, which now reads:

"(2) These Study Rules enter into force at the beginning of 2018/2019 academic year, and at that moment previous Study Rules No. IUS-SENAT-11-2488-2/2014 ceases to be in force.

(3) Upon student's written request, Graduate Council may approve completion of a study program in accordance with the previous Study Rules if the student is expected to complete his/her studies by the end of Fall semester of 2018/2019 academic year.

(4) Graduate Council may approve, without the request and after deadline proscribed in the previous paragraph, completion of study program for a student in accordance to the previous Study Rules - on case by case basis."

III

Article 29 of the Study Rules for Doctoral Studies at IUS, No. IUS-SENAT-11-1154/2018, dated May 25, 2018 is hereby amended and it now reads:

Article 29

(Entry into Force)

"(1) These Study Rules enter into force at the beginning of 2018/2019 academic year, and at that moment previous Study Rules No. IUS-SENAT-11-2488-3/2014) ceases to be in force.

(2) Upon student's written request, Graduate Council may approve completion of a study program in accordance with the previous Study Rules if the student is

expected to complete his/her studies by the end of Fall semester of 2018/2019 academic year.

(3) Graduate Council may approve, without the request and after deadline proscribed in the previous paragraph, completion of study program for a student in accordance to the previous Study Rules - on case by case basis."

IV

This Decision validates all proceedings which were done from the date of adoption of the study rules for the second and third cycle of study, up to the date of this Decision.

V

Other provisions of the study rules for second and third cycle studies remain unchanged.

VI

The decision comes into force on the date of its adoption.
