Pursuant to Article 119 of the Law on Higher Education ('Official Gazette of Sarajevo Canton', no 42/13 – Consolidated Text), based on the guidelines from Annex 3 of the ECTS User's Guide from 2009, Senate of the International University of Sarajevo, at its 38th meeting held on April 4, 2014, unanimously, brought the following

DECISION
Bologna Framework for Grade Distribution

I

In order to improve proper distribution of student's grades IUS has adopted Bologna Framework for Grade Distribution (hereinafter: Grade Distribution Table) as follows:

GRADE DISTRIBUTION TABLE	
IUS Internal Scale	Preferable Grade Distribution
A, A-, B+	20 %
B, B-, C+	35 %
C, C-, D+	25 %
D and below	20%
Overall	100%

II

Grade Distribution Table shows preferable distribution of grades with the aim of harmonization with standards of Bologna Process. It is designed as a guiding instrument for lecturer's grade distribution of various assessment components, including the final grade distribution.

Grade Distribution Table is a flexible instrument and it should be used as a complementary practice with already existing grading scale and practices at IUS.

III

Every lecturer should adjust the grade distribution in respective course to the Grade Distribution Table as much as possible. Serious deviation from the Grade Distribution Table may indicate that there are certain issues in methodological approach of a lecturer.

IV

The Deans are responsible for monitoring balanced distribution of grades in their Faculties.

V

This decision becomes effective as of the day it was rendered.

o Bolonjskom okviru distribucije ocjena

I

U cilju poboljšanja pravilne distribucije studentskih ocjena, IUS je usvojio Bolonjski okvir distribucije ocjena (u daljem tekstu: Distribucijska tabela), kako slijedi:

DISTRIBUCIJSKA TABELA	
IUS interna skala	Poželjna distribucija ocjena
A, A-, B+	20 %
B, B-, C+	35 %
C, C-, D+	25 %
D i niže	20%
Ukupno	100%

II

Distribucijska tabela predstavlja poželjnu distribuciju studentskih ocjena, u cilju harmonizacije sa standardima Bolonjskog procesa. Dizajnirana je kao uputstvo predavaču prilikom distribucije ocjena iz različitih komponenti na predmetu, uključujući i finalnu ocjenu.

Distribucijska tabela je fleksibilan instrument koji se koristi kao dopuna postojećoj skali ocjena i praksi na IUS-u.

III

Svaki predavač treba prilagoditi distribuciju ocjena na svom predmetu Distribucijskoj tabeli, u najvećoj mogućoj mjeri. Ozbiljna odstupanja od Distribucijske tabele mogu biti pokazatelj određenih problema u metodološkom pristupu predavača.

Dekani su odgovorni za nadzor balansirane distribucije ocjena na fakultetima.
