*According to the Article 61, Paragraph (1), Clause k) of the Law on Higher Education ("Official Gazette of Sarajevo Canton", issue 36/22), and the Article 121 of the Statute, No. IUS-SENAT-11-3326/24 dated October 22<sup>nd</sup>, 2024 - revised text, the Senate of the International University of Sarajevo (hereinafter: the Senate) on its 187<sup>th</sup> session held on April 25<sup>th</sup>, 2025, adopted the following*

**DECISION**

***on Amendment to the Book of Rules on recognition of passed examinations  
and of their equivalence at the International University of Sarajevo  
[No. IUS-SENAT-11-3088/24 of September 30th, 2024]***

**Article 1**

The Amendment to the ***Book of Rules on Recognition of Passed Examinations and of Their Equivalence at the International University of Sarajevo*** [No. IUS-SENAT-11-3088/24 of September 30th, 2024] are hereby adopted as follows:

**"The existing Article 28 shall be added with the new items so it will now read as follows:**

*"Article 28*

***Joint Study Programs - Recognition and Procedures***

- 1) *The provisions of this Book of Rules generally do not apply to students attending teaching activities organized as joint, interdisciplinary, or multidisciplinary studies in cooperation with domestic or foreign higher education institutions, in which case the automatic transfer and recognition of passed courses are regulated by the protocol on joint studies.*
- 2) *When it is stipulated by protocols that students of a joint study program will spend a period of study at the partner institution, the Student Affairs' Office shall, prior to the issuance of the diploma, obtain an official confirmation of the completion of all required courses from the partner institution and subsequently forward the request to the designated program coordinator for final verification.*
- 3) *The program coordinator shall prepare a report on the fulfillment of all academic obligations by the student, comparing the original curricula, which shall then be verified by the competent council's decision.*



- 4) *If any discrepancies are identified during the verification process regarding the structure, course titles, essential content, or ECTS credit values on the transcript compared to the original curriculum, the respective Faculty Council shall follow the general rules on equivalency set forth in this Book of Rules, initiate a committee procedure, and render a decision. This decision shall be submitted to the Student Affairs Office for entry into the Registry and diploma preparation.*
- 5) *In case where the joint program allows a student to enroll one or more specific courses in the ongoing semester at the partner institution, the student shall be required to provide official confirmation of successful course completion from that institution to the Student Affairs Office at the end of the respective semester. The competent Faculty Council at IUS shall make a decision on the recognition of such exams, which shall then serve as the basis for transcript entry by the Student Affairs Office.*
- 6) *If, in the case described in Paragraph 5 of this Article, any differences are found in the course title, essential content, ECTS credit value, or similar elements, the Faculty Council at IUS shall proceed in accordance with the general rules on equivalency outlined in this Book of Rules, initiate a committee procedure, issue a decision, and submit it to the Student Affairs Office.*

#### **Article 2**

The other articles from the Book of Rules remain unchanged.

#### **Article 3**

Upon the Decision on amendments, a new consolidated text of the *Book of Rules on recognition of passed examinations and of their equivalence at the International University of Sarajevo* can be issued referred to the number of this Decision along with the extension (-1) and the year of issuance.

#### **Article 4**

The Decision shall enter into force on the day of its adoption.
