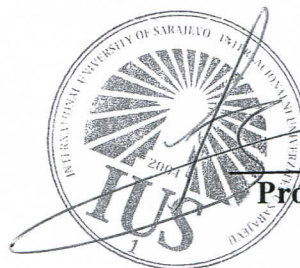

**I**



Faculty of Law shall allow the internal transfer quota of 10 students for the study program of the Faculty of Law in the Spring semester of the academic year of 2015/2016.
