**ODLUKU**  
**o izmjeni i dopuni Statuta**

**I**

Ovom Odlukom se donose izmjene i dopune Statuta Internacionalnog univerziteta u Sarajevu, broj IUS-SENAT 11-1720/2023 od 19.06.2023. godine (u daljem tekstu: Statut), u dijelu koji se odnosi na organizacione jedinice i nadležnost Senata do pune uspostave tijela nove organizacione jedinice, te se utvrđuje prečišćen tekst Statuta, kao sastavni dio ove Odluke.

**II**

Član 28. Statuta iz tačke I ove Odluke se mijenja, i sada glasi:

*„Član 28  
(Organizacione jedinice)*

*U sastavu Univerziteta, organizacione jedinice putem kojih se izvodi naučni, umjetnički, nastavni, naučnoistraživački i umjetničkoistraživački rad, integrirani su:*

- a) *Fakultet umjetnosti i društvenih nauka

### III

U članu 39. stav (1) iza tačke cc) dodaje se nova tačka dd) koja glasi:

*“dd) obavlja poslove iz nadležnosti komisije matičara u postupku osnivanja do pune uspostave tijela organizacione jedinice;”*

Dosadašnja tačka dd) postaje tačka ee).

### IV

U članu 134. dodaje se novi stav (5) koja glasi:

*“U postupku osnivanja do konstituisanja tijela nove organizacione jedinice, Senat u nadležnosti komisije matičara postupa i donosi odluke iz tačke (2), (3) i (4) ovog člana.”*

### V

Ovom odlukom se ispravlja tehnička greška u članu 48. stav (8) koji sada glasi:

*“Obrazložen prijedlog za razrješenje prorektora, zbog jednog ili više razloga navedenih u stavu (7) ovog člana, Senatu može podnijeti rektor ili Upravni odbor“.*

#### VI

Član 55. mijenja se, i sada glasi:

„Član 55.

(Centar za inovacije i poduzetništvo)

*Centar za inovacije i poduzetništvo ustanovljen je s ciljem stvaranja okvira za stalan razvoj inovacija i poduzetništva na Univerzitetu, kao i ukupnih kapaciteta iz oblasti rukovođenja organizacijama koje se bave inovacijama i poduzetništvom, a što se bliže uređuje općim aktom.“*

#### VII

Ostali dio Statuta ostaje neizmjenjen.

#### VIII

Utvrđuje se prečišćen tekst Statuta Internacionalnog univerziteta u Sarajevu (kao sastavni dio ove Odluke), koji obuhvata Statut broj IUS-SENAT 11-1720/2023 od 19.06.2023. godine i Odluku o izmjeni i dopuni Statuta broj: IUS-SENAT 11-3325/2024 od 22.10.2024. godine.

*Based on the Article 56 paragraph (2) and Article 61 paragraph (1) point c) of the Law on Higher Education ("Official Gazette of Sarajevo Canton", number: 36/22), the Decision of the Ministry for Science, Higher Education and Youth of the Sarajevo Canton on giving consent to the Proposal for Decision on Amendments to the Statute of the International University of Sarajevo, number: 27/03-02-23989-10/24 dated October 17th, 2024, upon the Prior Consent of the Board of Trustees, number: IUS-UO-08-23/2024 dated October 05th, 2024, the Senate of the International University of Sarajevo, on its 184th session held on October 22nd 2024, brings*

## DECISION

on amendments to the Statute

### I

This Decision brings amendments to the Statute of the International University of Sarajevo, number IUS-SENAT 11-1720/2023 dated June 19th, 2023 (hereinafter: the Statute), in the part that refers to the organizational units and competence of the Senate until all bodies of the new organizational unit are fully operational, and establishes the revised text of the Statute (as an integral part of the Decision).

### II

The Article 28 of the Statute from the item I of this Decision is amended and now reads as follows:

#### **"Article 28 (Organizational Units)**

The organizational units within the University through which scientific, artistic, educational, scientific-research, and artistic-research work is carried out are integrated as follows:

a) Faculty of Arts and Social Sciences

English name: Faculty of Arts and Social Sciences

Abbreviation: FASS

Address: Hrasnička cesta 15, 72 210 Ilidža

Programs of study: I, II, and III cycle;

b) Faculty of Business and Administration

English name: Faculty of Business and Administration

Abbreviation: FBA

Address: Hrasnička cesta 15, 72 210 Ilidža

Programs of study: I, II, and III cycle;

c) Faculty of Engineering and Natural Sciences  
English name: Faculty of Engineering and Natural Sciences  
Abbreviation: FENS  
Address: Hrasnička cesta 15, 72 210 Ilidža  
Programs of study: I, II, and III cycle;

d) Faculty of Law  
English name: Faculty of Law  
Abbreviation: FLW  
Address: Hrasnička cesta 15, 72 210 Ilidža  
Programs of study: I, II, and III cycle;

e) Faculty of Education  
English name: Faculty of Education  
Abbreviation: FEDU  
Address: Hrasnička cesta 15, 72 210 Ilidža

f) Faculty of Medical Sciences  
English name: Faculty of Medical Sciences  
Abbreviation: FMS

g) Research Institute  
English name: Research Institute"

### III

In the Article 39, Paragraph (1), the new item dd) is added, which reads:

“dd) performs the duties of the registry commission (within its competence) in the process of establishing new organizational units until they are fully operational;”

The existing item dd) becomes item ee).

### IV

In the Article 134, a new paragraph (5) is added, which reads:

*“In the process of establishing a new organizational unit until its bodies are fully operational, the Senate assumes the duties of the registry commission and makes decisions based on points (2), (3), and (4) of this Article.”*

#### V

This Decision corrects a technical error in the Article 48, paragraph (8), which now reads:

*"A reasoned proposal for the dismissal of the vice-rector, due to one or more reasons listed in paragraph (7) of this article, may be submitted to the Senate by the rector or the Board of Trustees".*

Paragraph (9) is deleted, and paragraphs (10) and (11) become paragraphs (9) and (10).

#### VI

The Article 55 is amended, and now reads:

*"Article 55 (Innovation and Entrepreneurship Center)  
The Innovation and Entrepreneurship Center was established with the aim of creating a framework for constant development of innovation and entrepreneurship at the University and the overall capacities in the field of management of organizations dealing with innovation and entrepreneurship, which is more closely regulated by a general act."*

#### VII

The rest of the Statute remains unchanged.

#### VIII

By this Decision the revised text of the Statute of the International University in Sarajevo is adopted as an integral part of this Decision, which includes the Statute, number IUS-SENAT 11-1720/2023 dated June 19<sup>th</sup> 2023 and the Decision on Amendments to the Statute number IUS-SENAT 11-3325/2024 dated October 22<sup>nd</sup> 2024.
