- d) preduzima aktivnosti i mjere na nivou Univerziteta radi uspostavljanja optimalne i poželjne saradnje po pitanju nastave sa drugim Univerzitetima u zemlji i inozemstvu;
- e) obavlja i druge poslove, koji po svojoj prirodi spadaju u nadležnost međuuniverzitetske saradnje a po nalogu rektora ili Upravnog odbora;
- f) obavlja i druge poslove u skladu sa Zakonom i ovim Statutom.

II

III

Appointed shall have competency and responsibility in coordinating the activities of:

- a) Office for Quality Assurance (QA);**
- b) Office for International Relations (IRO), and**
- c) General Affairs.**

Besides the abovementioned, Appointed will perform activities, as follows:

- a) to propose to the Rector appropriate solutions in accordance with the set policy in the area of teaching process;
- b) to coordinate activities at the University level related to making of curricula and syllabi and to monitor their implementation;
- c) to work on preparing and publishing of publication “Study at University”;
- d) to take activities and measures at the University level to establish optimal and desirable cooperation with universities from the country and abroad, which is related to teaching activities;
- e) to perform other activities which by their nature fall within the scope of activities of inter-universities’ cooperation, by order of the Rector or the Board of Trustees;
- f) to perform other tasks in accordance with the Law and the Statute.
