*Pursuant to the Articles 119 of the Law on Higher Education („Official Gazette of the Sarajevo Canton“, issue no 42/13 – Consolidated Text), the Senate of the International University of Sarajevo, at its 58<sup>th</sup> session held on January 25, 2016, unanimously, brought the following*

## **DECISION**

### **I**

All IUS teaching personnel are required to comply with the limitation of 5 courses (or maximum 30 ECTS) per semester or 10 ten courses (maximum 60 ECTS) per academic year for each IUS student.

### **II**

Exceptionally, students who failed or didn't sit for one exam in previous semesters can transfer one course to the next semester (register 5 + 1 course), in the following cases:

- If student had completed less than 30 ECTS credits during the first semester,
- If student had completed less than 60 ECTS credits during the second semester,
- If student had completed less than 90 ECTS credits during the third semester,
- If student had completed less than 120 ECTS credits during the fourth semester,
- If student had completed less than 150 ECTS credits during the fifth semester,
- If student had completed less than 180 ECTS credits during the sixth semester,
- If student had completed less than 210 ECTS credits during the seventh semester.

### **III**

Exceptionally, graduating students in their last semester may be allowed to register 5 + 1 course + graduation thesis.

This rule will not apply to students enrolled to IUS in academic year 2015/2016 or later.

### **IV**

This Decision becomes effective as of the day it was brought.

*Na osnovu člana 119. Zakona o visokom obrazovanju („Službene novine Kantona Sarajevo“, broj 42/13), Senat Internacionalnog univerziteta u Sarajevu, na 58. sjednici održanoj 25.01.2016. godine, jednoglasno, donosi sljedeću*

## ODLUKU

### I

Nalaže se svom nastavnom osoblju da prijave i broj predmeta svakog studenta ograničavaju na maksimalno pet (30 ECTS bodova) po semestru odnosno maksimalno deset (60 ECTS bodova) u toku jedne studijske godine.

### II

Izuzetno, studenti koji nisu položili ili nisu izašli na najmanje jedan ispit u prethodnim semestrima, mogu prenijeti jedan predmet u naredni semestar odnosno prijaviti 5 + 1 ispita, u slijedećim slučajevima:

- Ako je na kraju prvog semestra student ostvario manje od 30 ECTS bodova,
- Ako je na kraju drugog semestra student ostvario manje od 60 ECTS bodova,
- Ako je na kraju trećeg semestra student ostvario manje od 90 ECTS bodova,
- Ako je na kraju četvrtog semestra student ostvario manje od 120 ECTS bodova,
- Ako je na kraju petog semestra student ostvario manje od 150 ECTS bodova,
- Ako je na kraju šestog semestra student ostvario manje od 180 ECTS bodova,
- Ako je na kraju sedmog semestra student ostvario manje od 210 ECTS bodova.

### III

Izuzetno, studentima zadnjeg semestra na IUS-u može se dozvoliti prijava i završnog (diplomskog) rada, pored šest predmeta registrovanih na osnovu prethodnog člana ove Odluke.

Ovo pravilo neće se primjenjivati na studente upisane počev od studijske 2015./2016. godine.

### IV

Ova Odluka stupa na snagu danom donošenja.
