Pursuant to Article 126 of the Law on Higher Education (Official Gazette of Canton Sarajevo, issue No. 43/08, 18/10, and 15/13) and Article 3 of the Book of Rules on Publishing Activities, No. IUS SENAT 11-812/11 dated June 31, 2011, Senate of the International University of Sarajevo, on its 34th session held on October 31, 2013, unanimously, adopted the following

DECISION

I
